INSTRUCTIONS FOR CARROLL COUNTY KENNEL LICENSES:

BY MAIL

- 1. Complete this form. Be sure the correct kennel owner and street address appear on all applications. A valid vendor's license is required to apply for a kennel license, so make sure you fill in the vendor's license info.
- 2. List the breeds kept, along with the number of males and females over three (3) months of age for each breed.
- 3. Enclose a check or money order for the correct fees payable to the Carroll County Auditor. **Please do not send cash.** Before January 31, licensing rate is \$80.00 for the first five (5) tags and \$1.00 for each additional tag. After January 31, statutory late penalty increases the licensing rate to \$160.00 for the first five (5) tags. Fees can be verified by calling our office or checking our website at www.carrollcountyauditor.us. Your application cannot be processed without the correct fees.
- 4. Please mail the application, check or money order, and a self-addressed stamped envelope to:

 A receipt will be returned to you with your new license tag(s).
