ONLINE

Register your dog online at www.doglicenses.us/OH/Carroll. Online payment is credit card only, and a \$2.25 processing fee does apply.

BY MAIL

- 1. Complete this form. Be sure the correct owner, street address, and pet description(s) appear on all applications.
- 2. Use this form to register one (1) to five (5) dogs. If you need to register more than five (5) dogs, please list them on a separate sheet of paper and return it with this form.
- 3. Enclose a check or money order for the correct fees payable to the Carroll County Auditor. **Please do not send cash.** Fees can be verified by calling our office or checking our website at www.carrollcountyauditor.us.
- 4. Please mail the application, check or money order, and a self-addressed stamped envelope to: Carroll County Auditor, 119 S. Lisbon St, Suite 203, Carrollton, OH 44615 A receipt will be returned to you with your new license tag(s).

ORC 955.01 All dogs three months of age or older must be licensed. No dog shall be harbored, kept, or owned without displaying a valid registration tag. The law applies regardless of whether the dog is kept inside or outside.

ORC 955.01, .05 A penalty shall be assessed if Dog License is not secured on or before January 31, or within 30 days after the dog becomes three (3) months of age, is acquired, or is brought from outside the state.

ORC 955.09 Certificates of registration and registration tags shall be valid only during the calendar year or years for which they are issued.

Licenses purchased after July 1st for dogs under 3 months of age are half price (for 1 & 3 year licenses only).
